Patent and Trademark Transfer Agreement

between

Cognis Deutschland GmbH & Co. KG, Rheinpromenade 1, 40789 Monheim am Rhein

(hereinafter "COGNIS")

Cognis IP Management GmbH, Henkelstr. 67, 40589 Düsseldorf

(hereinafter „CIPM“)

and

Cognis Oleochemicals GmbH, Henkelstr. 67, 40589 Düsseldorf

(hereinafter "OLEOCHEMICALS")

Preamble

Under the German Business Transfer Agreement dated 21st December 2005 (hereinafter the "German Business Transfer Agreement") COGNIS has undertaken to carve-out and transfer its Oleochemicals Business [REDACTED] to OLEOCHEMICALS with effect as from 31st December 2005 (hereinafter the "Transfer Date"). For implementation of this Agreement, COGNIS and CIPM hereunder transfer to OLEOCHEMICALS the patents and trademarks which exclusively or predominantly relate to the Oleochemicals Business subject to the following terms.

1. *Transfer of Oleochemicals Patents and Trademarks*

- (a) COGNIS (to the extent COGNIS holds the relevant IP rights) and CIPM (to the extent CIPM holds the relevant IP rights) hereby transfer to OLEOCHEMICALS with economic and *in rem* effect as from the Transfer Date the patents and patent applications, as well as the trademarks and trademark applications listed in Schedule 1, as well as all corresponding patents, patent applications, utility models, trademarks and trademark applications, which have been filed by COGNIS and which claim the same priority (hereinafter the "Transferred Oleochemicals Patents and Trademarks").

(b) [REDACTED]

5. *Miscellaneous*

- (a) This Agreement is personal to the Parties. It shall not be assigned or otherwise transferred to any third party, unless otherwise agreed upon in writing.
- (b) This Agreement may not be changed or amended orally, but only in writing signed by both Parties.
- (c) Should any provision of this Agreement be or become invalid, such invalidity shall not affect the validity of the entire Agreement, however, that such provision shall be replaced by a regulation which comes closest to the original intention of the Parties.
- (d) The Agreement constitutes the entire agreement of the Parties in relation to its subject matter.
- (e) This Agreement shall be governed by and construed in accordance with the laws of the Federal Republic of Germany.
- (f) All disputes arising out of or in connection with this Agreement shall be settled amicably between the Parties. In case an amicable settlement cannot be reached, the matter shall be finally settled under the Rules of Arbitration of the International Chamber of Commerce by one or more arbitrators appointed in accordance with the said Rules. Place of arbitration shall be Düsseldorf.
