BETWEEN

- (1) TANG, Lai Chun, a citizen and a resident of Hong Kong Special Administrative Region c/o 8th Floor, Cheung Lung Industrial Building, 10 Cheung Yee Street, Cheung Sha Wan, Kowloon, Hong Kong ("The Assignor")

and

- (2) O.D.M. DESIGN & MARKETING LIMITED, a limited liability company incorporated under the laws of 8th Floor, Cheung Lung Industrial Building, 10 Cheung Yee Street, Cheung Sha Wan, Kowloon, Hong Kong ("The Assignee")

WHEREAS

- (A) The Assignor created a design for a Watch ("the Design") in about 3 Aug 2008 at which time he was the employee of the Assignee and made use of the Assignee's resources to create the Design. Representations of the Design are annexed hereto marked "A".
- (B) The Assignor has agreed to assign all rights in the Design to the Assignee on the terms set out herein and to execute this Assignment.

ASSIGNMENT

1. In consideration of the sum of HK\$1 (receipt of which the Assignor hereby acknowledges), the Assignor as beneficial owner hereby sells, assigns and transfers to the Assignee all his rights, title and interests in the Design which subsist anywhere in the world for the full period thereof (including, without limitation, the full and entire rights, title and interests in the Design for which an application for United States Patents was executed on the date hereof and may be granted therefor, to the full end of the term for which the said Patent may be granted, as fully and entirely as the same would have been held by the Assignor had this Assignment not been made), together with the right to sue for past infringements of any such right and to retain any damages obtained as a result of such action.
2. The Assignor confirms that the Design has not been previously registered for any article nor published or disclosed in the United States or elsewhere and he has never assigned any right in the Design to any third party or otherwise dealt in or with any such right.
3. The Assignor agrees to give whatever assistance the Assignee may reasonably require in order to perfect the Assignee's title to or enforce any such right (including, without limitation, requesting the United States Commissioner of Patents and Trademarks to issue the said Patent to and in the name of the Assignee).
4. The Assignor hereby waives absolutely his right to be identified as the author of the Design, his right to object to derogatory treatment thereof and any broadly equivalent rights he may have anywhere in the world insofar as it is legally possible.
5. This Assignment shall be governed by and construed in accordance with the laws of Hong Kong Special Administrative Region and the parties hereby submit to the

non-exclusive jurisdiction of the courts of Hong Kong Special Administrative Region.

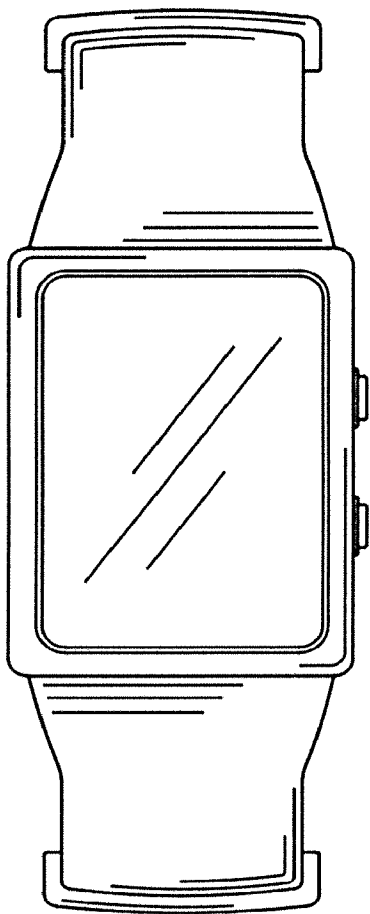

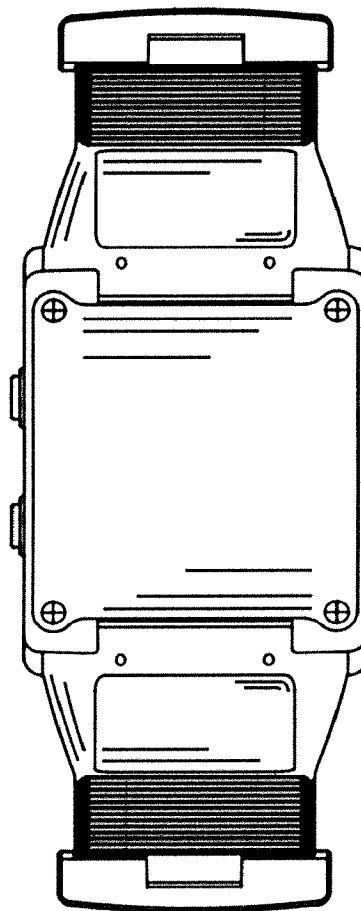

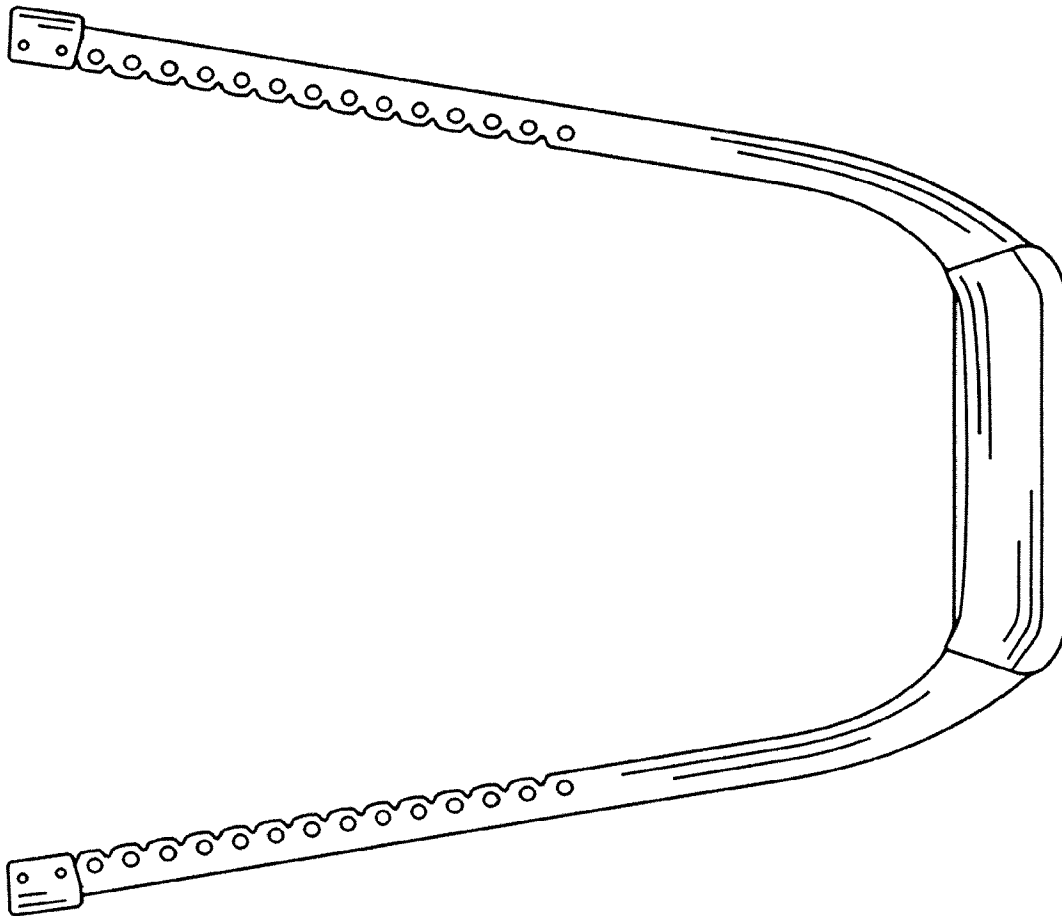

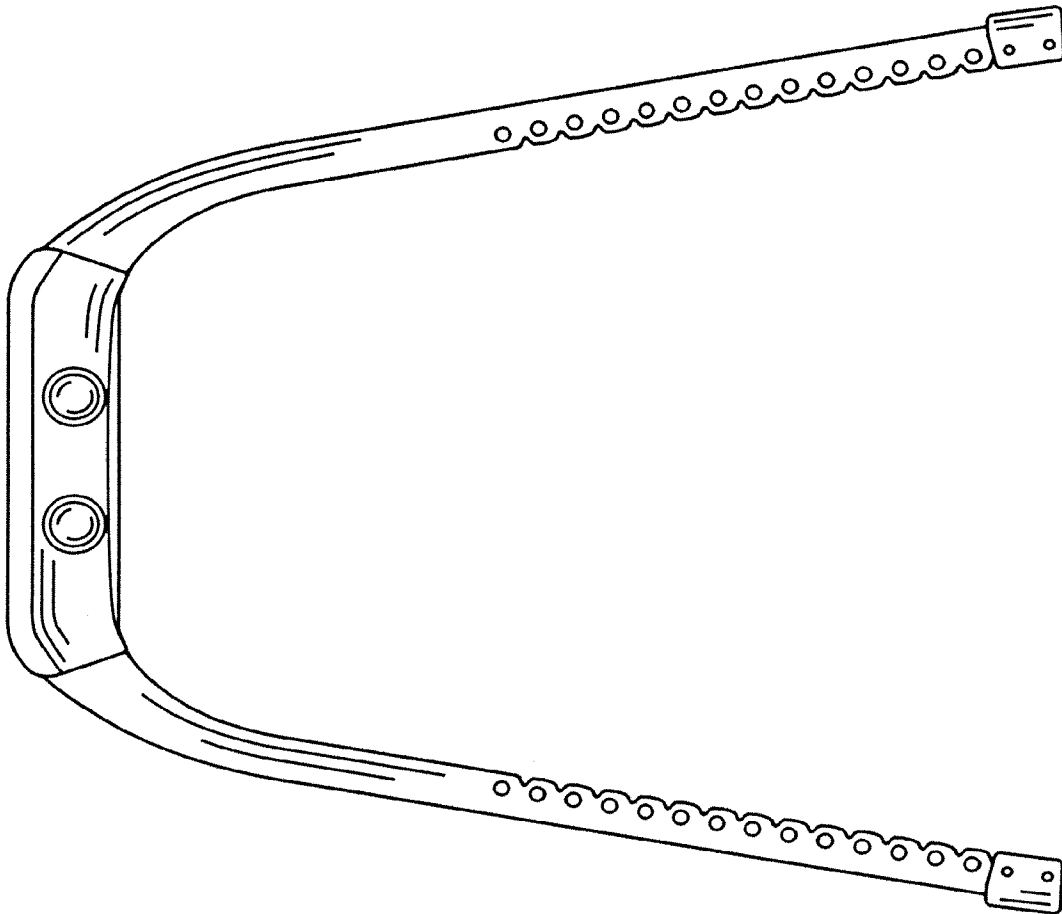

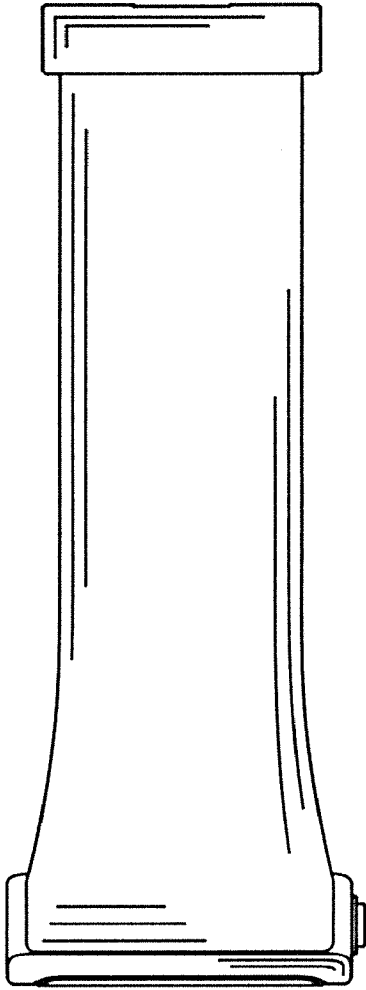

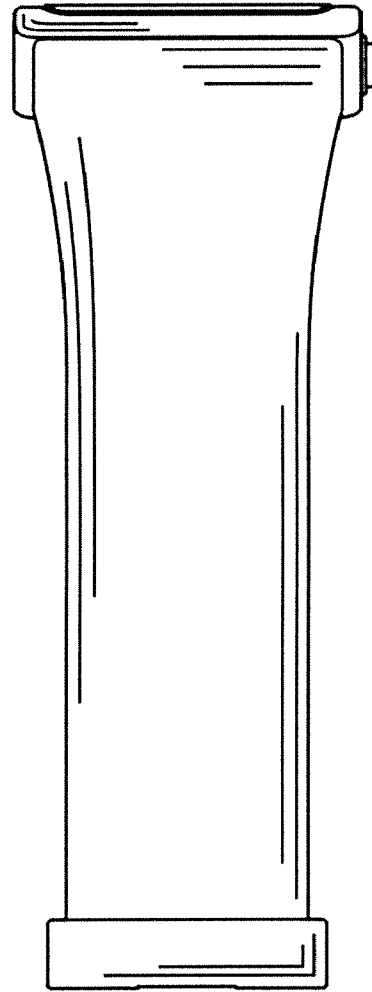
