- 4. The Assignor hereby waives absolutely his right to be identified as the author of the Design, his right to object to derogatory treatment thereof and any broadly equivalent rights he may have anywhere in the world insofar as it is legally possible.
- This Assignment shall be governed by and construed in accordance with the laws of Hong Kong Special Administrative Region and the parties hereby submit to the


non-exclusive jurisdiction of the courts of Hong Kong Special Administrative Region.









