ASSIGNMENT

WHEREAS, we, TOM SCHOENHERR, Argonnenstr. 22, D-70374 Stuttgart, Germany, and ANKE SALOMON, residing at Reinsburgstr. 72, D-70178 Stuttgart, Germany, have invented a new original and ornamental design for a FAUCET HANDLE for which we have made application for Letters Patent of the United States of America; and


file applications for patent in countries foreign to the United States, under international convention or otherwise, and the right to claim priority based on the first filed application; and we hereby authorize and request the Commissioner of Patents to issue all Patents on said United States applications to said corporation as assignee thereof.

FOR SAID CONSIDERATIONS, we hereby covenant and agree that we are the owner of the full title herein assigned and have the right to assign the same, and agree that we will communicate to said corporation or its representatives, any facts known to us respecting said invention or inventions and testify in any legal proceedings relating thereto when called upon, and will sign all instruments and documents and render such assistance which in the judgment of said corporation is necessary to vest in it and protect the legal title sought to be assigned.
