ASSIGNMENT

THIS ASSIGNMENT ("Assignment") is entered into as of 22 SEP 08, by FACET TECHNOLOGIES, LLC, a Georgia limited liability company, having its principal place of business at 112 Town Park Drive, Suite 300, Kennesaw, GA 30144 ("Assignor") in favor of ABBOTT DIABETES CARE INC., a Delaware corporation having a place of business at 1360 South Loop Road, Alameda, CA 94502 ("Assignee").

WHEREAS, Assignor and Assignee have entered into a Development, License and Intellectual Property Agreement dated as of August 1, 2005 ("Agreement");

Whereas, Assignor has acquired rights in certain inventions entitled LANCET, as set forth in United States Application Serial No. 29/319,139, filed June 4, 2008 (Attorney Doc. No. ABB-125-A);

WHEREAS, pursuant to and in accordance with the terms of the Agreement, Assignor is entering into this Assignment to evidence the transfer to Assignee of all right, title and interest in and to such inventions and application;

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignor hereby agrees as follows:

1. Assignment. Assignor hereby sells, assigns, and transfers, unto Assignee, its successors and assigns, the full and exclusive right, title, and interest throughout the world in and to: (a) the above-identified inventions and all improvements and modifications thereof, (b) the above-identified application and all other applications for patent in the United States and any countries foreign thereto for the above-identified inventions and all improvements and modifications thereof, (c) all patents which may issue from such applications in the United States and countries foreign thereto, (d) all divisions, continuations, reissues, and extensions of such applications and patents, (e) the right to claim for any of such applications the full benefits and priority rights under the International Convention and any other international agreement to which the United States adheres; and (f) such other rights in respect of such inventions or applications as have been assigned to Assignor by the inventors named in such applications; all of the foregoing right, title, and interest to be held and enjoyed by Assignee, its successors and assigns, to the full end of the term or terms for which any and all such patents may be granted as fully and entirely as would have been held and enjoyed by Assignor had this Assignment not been made.



Assignor shall provide to provide all reasonable assistance to Assignee, its successors and assigns, in obtaining and enforcing proper title in and protection for such invention or inventions, improvements, and modifications under the intellectual property laws of the United States and countries foreign thereto.

4. Authorization to Identify Application. Assignor hereby grants to the law firm of Young, Basile, Hanlon, MacFarlane & Helmholdt, P.C. the power and authority to insert in this Assignment any further identification which may be necessary or desirable to comply with the rules of the U.S. Patent and Trademark Office for recordation of this Assignment. Assignor acknowledges that the attorneys and agents of the law firm of Young, Basile, Hanlon, MacFarlane & Helmholdt, P.C. do not represent Assignor or Assignor's legal interests, but instead represent the interests of Assignee.
