CONFIRMATION OF TRANSFER OF PATENT RIGHTS FROM L-1 SECURE  
CREDENTIALING, INC. (FORMERLY KNOWN AS DIGIMARC CORPORATION) TO  
DIGIMARC CORPORATION (FORMERLY KNOWN AS DMRC CORPORATION)

WHEREAS, L-1 SECURE CREDENTIALING, INC. (formerly known as Digimarc Corporation) a Delaware corporation ("L-1 Secure Credentialing"), held certain rights to the patents and patent applications listed below.

WHEREAS, DMRC LLC, a Delaware limited liability company and formerly a wholly owned subsidiary of the former Digimarc Corporation ("DMRC LLC"), entered into a Bill of Sale, Assignment and Assumption Agreement with the former Digimarc Corporation, dated as of August 1, 2008 (the "Assignment") pursuant to the Separation Agreement, dated as of August 1, 2008 (the "Separation Agreement"), by and among the former Digimarc Corporation, DMRC LLC, DMRC Corporation, a Delaware corporation and a wholly-owned subsidiary of DMRC LLC ("DMRC Corp"), and, solely with respect to Section 3.02, Section 4.09(b)(iii) and Section 4.13 thereof, L-1 Identity Solutions, Inc., a Delaware corporation.

WHEREAS, as a result of that Separation Agreement and Assignment, L-1 Secure Credentialing assigned all of its right, title and interest in and to those patents and patent applications to DMRC LLC.

WHEREAS, following such assignment, DMRC LLC entered into an Agreement and Plan of Merger with DMRC Corp (the "Merger Agreement") whereby DMRC LLC and DMRC Corp merged (the "Merger"), and, as a consequence of the Merger, all right, title and interest of L-1 Secure Credentialing and DMRC LLC under those patents and patent applications was transferred to, and assumed by DMRC Corp. As a result of that Merger, DMRC LLC no longer exists.

WHEREAS, on September 3, 2008, DMRC Corp changed its name to Digimarc Corporation.

WHEREAS, L-1 Secure Credentialing and Digimarc Corporation confirm that pursuant to the Separation Agreement, the Assignment and the Merger Agreement, L-1 Secure Credentialing has transferred to Digimarc Corporation the full right, title and interest that L-1 Secure Credentialing had in and to those patent applications and patents.

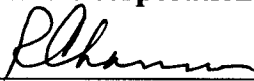
