**Recitals:**

1. The Assignor hereby ASSIGNS absolutely to the Assignees free from incumbrances:

1.1 all its right title and interest in and to the Patent Cases to the intent that the grant of any patents on the Patent Cases shall be in the name of and vest in the Assignees; together with all rights and powers arising or accrued from the same including the right to sue for damages and other remedies in respect of any infringement of such rights or other acts within the scope of the claims of any published specificationsof the Patent Cases or accompanying any Patent Cases therefor or accompanying the Patent Cases prior to the date of this Agreement;

1.2 the right to apply for prosecute and obtain patent or similar protection throughout the world in respect of the inventions claimed in the Patent Cases including the right to claim priority therefrom to the intent that the grant of any patents or similar protection shall be in the name of and vest in the Assignees.

2. The Assignor further covenants as follows:-

- 2.1 that at the request and cost of the Assignees it will at all times after the date of this Assignment do all such acts and execute all such documents as may reasonably be necessary or desirable both to secure the vesting in the Assignees of all rights assigned to the Assignees hereunder and to assist in the resolution of any question concerning the Patent Cases.




