We will communicate to Assignee, its successors and assigns or their representatives, any facts known to us respecting said invention and improvements; and, at the expense of Assignee, we will testify in any legal proceedings relating thereto. sign all lawful papers, execute all divisional, continuing, reissue and substitute applications, make all rightful oaths and declarations, and, in addition, execute any and all documents required to vest title in Assignee and to aid Assignee to obtain and enforce proper protection for said invention in all countries.

We covenant that we have the full right to convey the interest assigned by this Assignment, and that we, individually or together, have not executed and will not execute any agreement in conflict with this Assignment.

This Assignment shall be binding on the parties' successors, assigns and legal representatives.

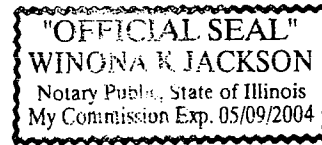

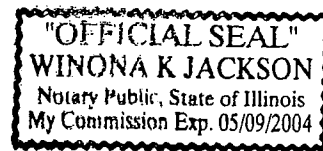
