AND I HEREBY covenant that I have full right to convey the entire interest herein assigned, and that I have not executed, and will not execute, any agreement in conflict herewith;

AND I HEREBY further covenant that I will communicate to said VIA Technologies, Inc., or to its successors, assigns and legal representatives, any facts known to me respecting said invention, and at the expense of said VIA Technologies, Inc., testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, reissue and substitute applications, make all lawful oaths, and generally do everything possible to aid said VIA Technologies, Inc., its successors, assigns and nominees to obtain and enforce proper patent protection for said invention in all countries.

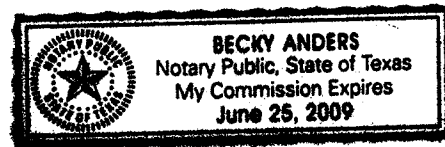
