
AND WHEREAS, at the time the invention was made, I was under an obligation to assign all of our right, title, and interest in our said invention to Greatbatch Ltd.

And I hereby authorize and request the Commissioner of Patents and Trademarks to issue said United States Letters Patent to said Greatbatch Ltd. as the assignee of the whole right, title, and interest thereto.

And I further agree to sign and properly execute such necessary and lawful papers for application for foreign patents, for filing subdivisions of said application for patent, and for obtaining any reissue or reissues of any Letters Patent which may be granted for our aforesaid invention, as the assignee thereof shall hereafter require and prepare at its own expense.
