Craig Helm of 16 Locust Avenue, Westmont, NJ 08108, Hylsa Garcia of 918 McLain Street, Elizabeth, NJ 07202, have made certain new and useful inventions in **Insecticidal and Miticidal Mixtures of Bifenthrin and Cyano-Pyrethroids**, for which a non-provisional patent application was filed in the U.S. Patent and Trademark Office on June 20, 2008, and assigned United States Serial No. 12/158,487, claiming priority of International Application No. PCT/US2006/049062, filed on December 21, 2006, which claims the benefit of U.S. Provisional Application 60/752,979, filed December 22, 2005.
