The ASSIGNOR further agrees to execute any powers-of-attorney, applications, assignments, declarations, affidavits, and any other papers necessary to perfect such interest in ASSIGNEE, its successors, assigns, and legal representatives.

The ASSIGNOR hereby further agrees that he will communicate to the ASSIGNEE, or its successors, assigns, and legal representatives, any facts known to him respecting any improvements in the invention. At the expense of the ASSIGNEE, ASSIGNOR agrees to testify in any legal proceedings; sign all lawful papers; execute all divisional, continuation, continuation-in-part, reissue, and substitute applications; make all lawful oaths; and generally do everything possible to vest title in the ASSIGNEE and to aid the ASSIGNEE, its successors, assigns, and legal representatives to obtain and enforce proper protection for the invention in all countries.

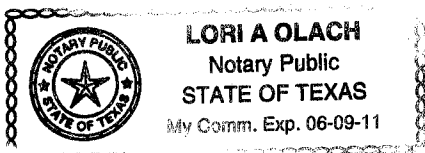
