## **ASSIGNMENT OF PATENT APPLICATION**

For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, I, Sun, Fu-Cheng of Taipei County, Taiwan, have invented certain new and useful improvements as set forth in the specification of the application for the United States patent, which was filed on October 30, 2008, and assigned Serial No. 29/327,075, that has been executed by the undersigned prior hereto or concurrently herewith on the dates indicated and is entitled:

### **“Electronic Tape Measure”**

- 2) authorize the ASSIGNEE to apply for and receive a patent or patents of foreign countries for said improvements, and to claim all rights of priority without further authorization from the undersigned;
- 3) agree to execute all lawful papers and documents, and perform all lawful acts useful in connection with said United States and foreign applications, at the request and expense of the ASSIGNEE, in obtaining and enforcing patents for said improvements in all countries;
- 4) authorize and request the Commissioner for Patents to issue any patents granted for said improvements to the ASSIGNEE for its interest and for the sole use and benefit of its successors, legal representatives and assigns; and
- 5) warrant and represent that any assignment, grant, mortgage, license, contract, or other agreements that conflicts with this assignment has not been entered, and will not be entered by the undersigned.
