Confirmation of Patent Transfer and Assignment

This Confirmation Agreement (this "Agreement") is made as of June 18, 2008 by and between Marvell Software Solutions Israel Ltd., an Israeli limited company (hereinafter "MSSI"), and Marvell International Limited, a Bermuda corporation (hereinafter "MIL"). Each party hereto may also be referred to hereunder as a "Party" and the "Parties", respectively.

WHEREAS, MSSI and MIL wish to confirm the transfer and assignment of certain patents and patent applications pursuant to the IP Purchase and Assignment Agreement dated January 9, 2008 executed by the Parties.

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby agree as follows:

MSSI and MIL hereby confirm the transfer and assignment of all the patents and patent applications ("Patents") as identified in Exhibit A attached hereto pursuant to Section 2 of the aforementioned IP Purchase and Assignment Agreement.

MSSI hereby confirms that MSSI has sold, assigned, conveyed and transferred onto MIL, its successors and assigns, the entire right, title and interest in and to the Patents, including any patents issuing from or based upon all patent applications thereon, and all inventions described and claimed therein or entitled to the benefit thereof, in any and all Letters Patent therefor, and in any and all continuations, continuations-in-part, divisionals, reissues, re-examinations or extensions of the Patents to the full end of the term(s) for which such Letters Patent issue, and including, without limitation, the right to sue for and recover damages for any past, present or future infringement of such Patents, the same to be held and enjoyed by MIL for its own use, and for its legal representatives and assigns, to the full end of the term for which patents are granted, as fully and entirely as the same would have been held by MSSI had this assignment and sale not been made.

MSSI authorizes and requests the Commissioner of Patents and Trademarks of the United States, and any officer of any country or countries foreign to the United States, whose duty it is to issue patents or other evidence or forms of intellectual property protection or applications as aforesaid, to issue the same to MIL and its successors, assigns and other legal representatives in accordance with the terms of this Agreement.




