Assignor further transfers and assigns to Assignee all causes of action, rights and remedies arising under the Letters Patent prior to and after the date of this Assignment.

Assignor also assigns to Assignee, all right, title and interest in and to the Invention disclosed in said application throughout the world, including the right to file applications and obtain patents, utility models, industrial models and designs throughout the world, including all rights to publish cautionary notices reserving ownership of said Invention and all rights to register said Invention in appropriate registries; and Assignor further agrees to execute any and all powers of attorney, applications, assignments, declarations, affidavits, and any other papers in connection therewith necessary to perfect such right, title and interest in Assignee.

Assignor will communicate with Assignee, its successors and assigns or their representatives, any facts known to it respecting said Invention; and, at the expense of Assignee, we will testify in any legal proceedings relating thereto, sign all lawful papers, execute all divisional, continuing, reissue and substitute applications, make all rightful oaths and declarations, and, in addition, execute any and all documents required to vest title in Assignee and to aid Assignee to obtain and enforce proper protection for said Invention in all countries.


