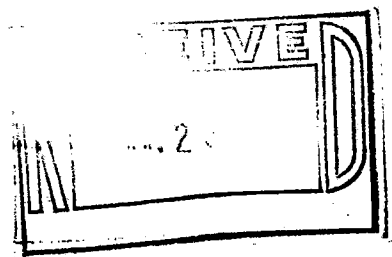

ASSIGNMENT OF MEDASORB ASSIGNMENT

For good and valuable consideration, receipt of which is hereby acknowledged, and intending to be legally bound hereby, Purolite International Ltd., a United Kingdom corporation, and Bro-Tech Corporation, a Delaware corporation, hereby assign, transfer and convey free and clear of any liens or encumbrances whatsoever to Stefan Brodie and Donald Brodie, as co-owners, together with their successors and/or assigns, all right, title and interest in and to the MedaSorb Assignment, as set forth in the Stipulated Order and Settlement Agreement by and between Bro-Tech Corporation and Purolite International, Ltd., on the one hand, and MedaSorb Corporation on the other hand, effective August 7, 2006, entered in Civil Action No. 03-232, in the United States District Court for the Eastern District of Pennsylvania ("Settlement Agreement").

The MedaSorb Assignment constitutes the irrevocable sale, assignment and transfer to Assignor of an equal, undivided ownership interest within the United States and

territorial possessions and in all foreign countries to the inventions which are claimed in the MedaSorb Patents, as defined in the Stipulated Order and Settlement Agreement, and to the inventions which are disclosed in the MedaSorb Patent application, all as is contained with paragraph 3 of the Settlement Agreement.

By this Assignment, Assignor transfers exclusively to Stefan Brodie and Donald Brodie, as co-owners, includes all benefits and rights to royalties for sales, royalties for replacement products, payments for license sales, and the rights, title and interest vested in Assignors pursuant to paragraphs 4(b), 4(e), 4(f) and 5 of the Settlement Agreement and elsewhere.

By this Assignment, Assignor transfers and conveys exclusively to Stefan Brodie and Donald Brodie, as co-owners, each and every right, benefit and entitlement vested in and/or belonging to Assignor, including the rights to receive each and every benefit of the Assignor under the Settlement Agreement and the rights of the Assignor to enforce and/or obtain the benefits and interests of the Assignor under the Settlement Agreement.


The Settlement Agreement is attached hereto as Exhibit "A."


This Assignment shall be governed by the laws of the Commonwealth of Pennsylvania, without regard to its principals regarding conflicts of law.


