ASSIGNMENT

WHEREAS, I, Chih-hung Chang, of Corvallis, Oregon, have invented a certain invention as described in the following patent applications:

U.S. Provisional Patent Application No. 60/701,810, filed on July 22, 2005, entitled "METHOD AND APPARATUS FOR CHEMICAL DEPOSITION,"

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, I, Chih-hung Chang, hereby sell, assign and transfer to State of Oregon acting by and through the State Board of Higher Education on behalf of Oregon State University the full and exclusive right, title and interest in and to said invention, patent applications and patent rights throughout the world, including foreign patent priority rights, the right to file and prosecute International Applications under the Patent Cooperation Treaty, and the right to file and prosecute applications under the European Patent Convention; said invention, the patent applications and letters patent in this or any foreign country, and all divisions, continuations, reissues and extensions thereof, to be held and enjoyed by State of Oregon acting by and through the State Board of Higher Education on behalf of Oregon State University for its own use and benefit, and for its successors and assigns to the full end of the term for which letters patent may be granted in this or any foreign country, as fully and entirely as the same would have been held by me had this assignment and sale not been made, and covenant that I have full right so to do, and agree that I will communicate to State of Oregon acting by and through the State Board of Higher Education on behalf of Oregon State University, or its successors and assigns, any facts known to me respecting said invention, and testify in any legal proceeding, sign all lawful papers,

execute all divisional, continuing and reissue applications, make all rightful oaths, and do everything possible to aid State of Oregon acting by and through the State Board of Higher Education on behalf of Oregon State University, its successors and assigns to obtain and enforce proper patent protection for said invention in this or any foreign country.

I hereby grant the law firm of Klarquist Sparkman, LLP, the power to insert on this Assignment any further information which may be necessary or desirable in order to comply with all applicable legal requirements, including the rules of the United States Patent and Trademark Office, for submitting and recording this document.

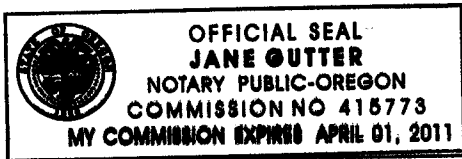
