PATENT ASSIGNMENT

WHEREAS, CESARE PICCHIO, (hereinafter referred to as PICCHIO) whose full post office address is Via Podgora 10, 20057 Vedano Al Lambro (MI), Italy, has invented an invention entitled: **CANTILEVERED SLIDING-STYLE DOOR** as described in Canadian Patent Application No. 2,599,045 filed August 27, 2007; United States Patent Application No. 12/198,924 filed August 27, 2008 and European Patent Application No. 08105164.1 filed August 27, 2008;

AND PICCHIO hereby authorizes and requests the Commissioner of Patents to issue said Letters Patent to UNIFOR S.p.A., the Assignee of the entire right, title and interest in and to the same, for its sole use and benefit; and for the use and benefit of its successors and assigns, to the full end of the term for which Letters Patent may be granted, as fully and entirely as the same would have been held by them had this Assignment and sale not been made;


AND PICCHIO hereby authorizes and empower said Assignee, its successors, assigns and legal representatives or nominees, to invoke and claim for any applications for patent or other form of protection for said invention filed by it or them, the benefit of the right of priority provided by the International Convention for the Protection of Industrial Property, as amended, or by any convention which may henceforth be

substituted for it, and to invoke and claim such right of priority without further written or oral authorization from them, and PICCHIO hereby assigns to said assignee all their said right to claim such priority in any country from said patent applications;

PICCHIO hereby authorize and grant to the firm RIDOUT & MAYBEE LLP of 225 King Street West, 10th Floor, Toronto, Ontario, M5V 3M2, Canada, the power to insert on this Assignment such further identification which may be necessary or desirable in order to comply with the patent regulations of any country for recordation of this document.
