DEVICE AND METHOD FOR DETECTING SULFUR DIOXIDE AT HIGH TEMPERATURES

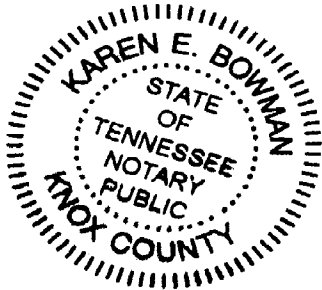

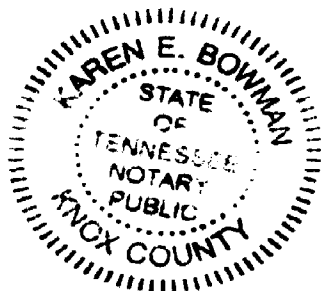
