
WHEREAS, WE, EDWARD C. BREMER; ALEXANDER M. McQUEEN;

any officials of foreign countries whose duty it is to issue patents on applications as


aforesaid, to issue all patents for said invention to PSC Scanning, Inc. in accordance with the terms of this Assignment.
