

AND I authorize the law firm of King & Schickli, PLLC to insert the serial numbers and filing dates of the corresponding PCT Patent Application and of and U.S. Patent Application resulting from entry into the national stage in the United States of America;

AND I request of the Commissioner of Patents and Trademarks or the corresponding official in any foreign country in which a patent or patents may issue for said inventions to issued said patent or patents to ALLTECH, INC., its legal representatives, successors or assigns, as the sole owner of the entire right, title and interest in and to said patents and the inventions covered thereby.


