Company agrees that this executed document is recordable evidence of such transfer and assignment and further agrees to perform at Recipient's expense, upon reasonable notice, such lawful acts and to execute any and all patent applications, assignments, affidavits, and any other papers in connection therewith necessary to perfect such foreign patent rights.
