The foregoing covenant and agreement shall inure to the benefit of the assigns and legal representatives of the undersigned and Assignee; and the undersigned authorize the Commissioner of Patents and Trademarks of the United States or non-US equivalent thereof to issue the Letters Patent or similar legal protection to the Assignee.
