## ASSIGNMENT

Whereas, by virtue of an Assignment recorded in the United States Patent and Trademark Office on Reel 021618, Frame 0199, on October 1, 2008, Citizen Electronics Co., Ltd. (hereinafter ASSIGNOR), a corporation having a place of business at 1-23-1, Kamikurechi, Fujiyoshida-shi, Yamanashi, Japan, is the owner of the entire right, title and interest in and to application for United States Letters Patent, Serial No. 11/758,191, filed June 5, 2007, in the name of K. Ishihara et al for "Sheet Switch Module", and of the invention therein described; and

Now, Therefore, in consideration of the sum of Ten Dollars (\$10.00) paid by Assignee to Assignor and other good and valuable consideration, the receipt of which is hereby acknowledged, Assignor has sold, assigned and transferred and by these presents does hereby sell, assign and transfer unto the said Assignee, fifty percent (50%) of the entire right, title and interest in and to the said invention within the United States of America and its territorial possessions and in and to any United States Letters Patent that may be granted therefor and in and to the said application and in and to any and all divisions, reissues, continuations and extensions thereof and in and to any Letters Patent that may be granted thereon, together with such 50% right to extend the protection of such Letters Patent to the

various territorial possessions now owned or which may be hereafter acquired by the United States of America, all said 50% rights to be held and enjoyed by Assignee to the extent hereby assigned for its own use and enjoyment and for the use and enjoyment of its successors, assigns, or nominees to the full end of the term or terms for which said Letters Patent may be granted as fully and entirely as the same would have been held and enjoyed by Assignor if this 50% assignment, transfer and sale had not been made.

Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks to issue said Letters Patent, when granted, to both said Assignor and said Assignee, as the assignee of its 50% right, title and interest in and to the same, for the sole use and enjoyment of both said Assignee and said Assignor, their successors, assigns, or nominees.
