ASSIGNMENT OF PATENT APPLICATION

WHEREAS, WE, EDWARD E. 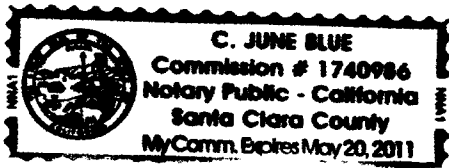

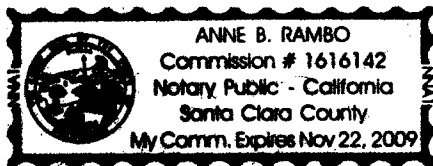

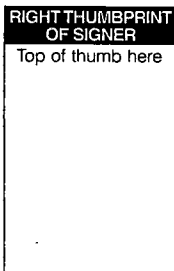
