TERMINATION OF SECURITY INTEREST IN

INTELLECTUAL PROPERTY

This Termination of Security Interest in Intellectual Property (the "Termination"), dated as of November 19, 2008, is executed by SUNTRUST BANK ("Bank"), in favor of SO DELAWARE CORPORATION (f/k/a SILICON OPTIX INC., as successor in interest to TERANEX, INC.), a Delaware corporation (together with its successors and assigns, "Grantor").

RECITALS

A. Reference is made to that certain Amended and Restated Security Agreement, dated as of March 31, 2003 (the "Agreement"), by and between Bank and Grantor, pursuant to which Grantor granted a security interest in all patents to secure the obligations of Grantor under the Loan Agreement (as defined in the Agreement).

B. Pursuant to the terms of the Agreement, Grantor granted to Bank a security interest in all of Grantor's right, title and interest in and to, all "general intangibles" (as defined in the Uniform Commercial Code in effect in the State of Florida from time to time, as amended (the "Code")) including, without limitation, payment intangibles, contract rights, rights to payment, rights arising under common law, statutes, or regulations, choses or things in action, goodwill, patents, trade names, trademarks, service marks, copyrights, blueprints, drawings, purchase orders, customer lists, monies due or recoverable from pension funds, route lists, rights to payment and other rights under any royalty or licensing agreements, infringement claims, computer programs, information contained on computer disks or tapes, software, literature, reports, catalogs, insurance premium rebates, tax refunds, and tax refund claims, amounts payable to Grantor from any employee benefit plan, rights and claims against carriers and shippers, rights to indemnification, business interruption insurance and proceeds thereof, property, casualty or any similar type of insurance and any proceeds thereof, any Supporting Obligations (as defined in the Agreement) in respect thereof, and any other personal property other than goods, Accounts, Investment Property, Negotiable Collateral and Chattel Paper (each, as defined in the Code) (the "General Intangibles").

C. The Agreement was filed with the United States Patent and Trademark Office on June 4, 2004, at Reel/Frame 015442/0595, to evidence the security interest granted under the Agreement.

D. Bank has agreed to release its security interest in the General Intangibles, including, without limitation, all patents.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Bank expressly terminates and releases its security interest in all of Grantor's right, title and interest in and to all patents (including, without limitation, those listed on Schedule A hereto).
