## ASSIGNMENT

WHEREAS, I, among the following inventors, Pathi Laxminarayan SRINIVAS, Rajendra Narayanrao KANKAN, Dharmaraj Ramachandra RAO, and Sandip VASANT CHIKHALIKAR, am an inventor of **SYNTHESIS OF 4-[1-(4-CYANO PHENYL)-1-(1,2,4-TRIAZOL-1-YL)METHYL] BENZONITRILE AND 4-[1-(1H-1,2,4-TRIAZOL-1-YL)METHYLENE BENZONITRILE INTERMEDIATE** (the "Invention"), and of an application for United States Patent disclosing said invention, Serial No. 12/282,859, filed September 12, 2008, also known as attorney docket number PAC/26002 US (4137-04300); and

And I hereby authorize and request the Commissioner of Patents and Trademarks to issue any and all Letters Patent of the United States on said Invention or resulting from said application and from any and all divisions, continuations, and reissues thereof, to CIPLA, as assignee of my entire interest, and hereby covenant that I have the full right to convey the entire interest herein assigned, and that I have not executed and will not execute any agreement in conflict herewith.

And I further hereby covenant and agree that I will, at any time, upon request, execute and deliver any and all papers that may be necessary or desirable to perfect the title of said Invention and to such Letters Patent as may be granted therefor, to CIPLA, its successors, assigns, or other legal representatives and that if CIPLA, its successors, assigns or other legal representatives shall desire to file any divisional or continuation applications or to secure a reissue of such Letters Patent, or to file a disclaimer relating thereto, I will upon request, sign all papers, make all rightful oaths and do all lawful acts requisite for the filing of such divisional or continuation application, or such application for reissue and the procuring thereof, and for the filing of such disclaimer, without further compensation but at the expense of said assignee, its successors, or other legal representatives.

And I do further covenant and agree that I will, at any time upon request, communicate to CIPLA, its successors, assigns or other legal representatives, such facts relating to said Invention and Letters Patent or the file history thereof as may be known to me, and testify as to the same in any interference or other litigation when requested so to do, without further compensation but at the expense of said assignee, its successors, or other legal representatives.
