

I further covenant and agree, that I, my executors and administrators, shall do all lawful acts and things and make, execute and deliver without further compensation, any further documents or instruments that may be deemed necessary by the Assignee, its successors and assigns, to file applications for said invention in the United States of America, and that may be necessary to vest in said Assignee, its successors and assigns, the title herein conveyed or intended to be conveyed, and to enable such title to be recorded in the United States Patent and Trademark Office.

And I further covenant and agree, that I, my executors and administrators, will at any time, upon request, communicate to the Assignee, its successors, and assigns, any facts relating to said invention and the history thereof, known to me or to my executors and administrators, and that I will testify as to the same in any interference, litigation or other proceeding when requested to do so by the Assignee, its successors and assigns.
