ASSIGNMENT OF PATENT

This ASSIGNMENT AGREEMENT ("Assignment Agreement") is made and entered into by and between KRONOS ADVANCED TECHNOLOGIES, INC., a Nevada corporation having a principal address at 464 Common Street, Suite 301, Belmont, MA 08052 ("Kronos") and TESSERA, INC., a Delaware corporation having an address at 3099 Orchard Drive, San Jose, CA 95134 ("Tessera").

1. Kronos and Tessera have entered into an Intellectual Property Transfer and License Agreement (the "IP Transfer Agreement"), dated March 28, 2008 (the "Effective Date").

2. Kronos has assigned to Tessera Kronos' Patent Rights in and to certain Transferred Technology defined in the IP Transfer Agreement and Tessera accepts the assignment of the Patent Rights in and to the Transferred Technology identified below under the terms and conditions set forth in the IP Transfer Agreement.

3. **Assignment.** Kronos hereby confirms that it has assigned and conveyed to Tessera Kronos's (and its Affiliates') entire right, title and interest in and to the Patent Rights of US Patent Application No.11/046,711 issued as US 7,248,003. Patent Rights are defined in the IP Transfer Agreement as all rights in and to U.S. and foreign patents and patent applications claiming the inventions or discoveries made, developed, conceived, or reduced to practice, including all divisions, substitutions, continuations, continuations-in-part, and any reissues, re-examinations and extensions thereof.

4. Such assignment was effective as of the Effective Date of the IP Transfer Agreement.
