
by said Company as fully and exclusively as they would have been by us had this assignment and transfer not been made;

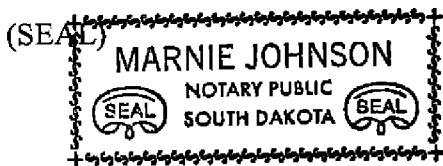

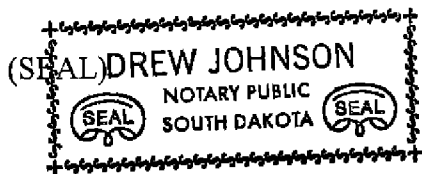

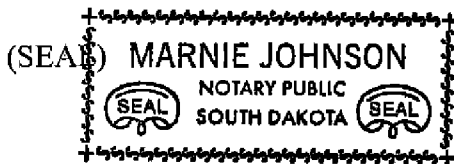
