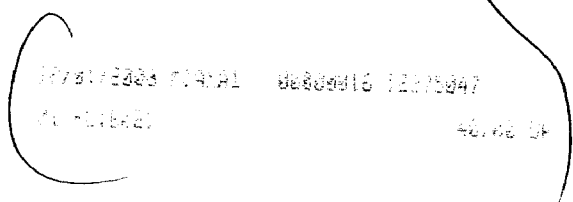

ASSIGNMENT

WHEREAS, **Dan Pei**, a citizen of China, residing at 20 Newport Parkway Apt 1701, Jersey City, NJ, 07310, U.S.A.; **Ricardo Oliveira**, a citizen of Portugal, residing at 1561 S Barrington Ave #102, Los Angeles, CA 90025, U.S.A; and **Walter Willinger**, a citizen of the United States of America, residing at 66 Noe Avenue, Madison, NJ, 07940, U.S.A.; hereinafter called the "Assignors," have made the invention described in the United States patent application entitled "**Methods and Apparatus to Infer the Status of Border Gateway Protocol Sessions**", Attorney Docket No. 20103/2008-0271, for a full description of which reference is here made to an application for Letters Patent of the United States filed herewith; and
