AND, I further covenant and agree that each time request is made, I will, without undue delay and without additional consideration: execute and deliver all such papers as may be necessary or desirable to perfect the title to said inventions or improvements, said application and said Letters Patent to said ASSIGNEES, their successors, assigns, nominees or legal representatives; communicate to said ASSIGNEES, or to their nominees all known facts respecting said inventions or improvements, said application and said Letters

Patents; testify or otherwise participate in any legal proceedings; and generally do everything possible to aid said ASSIGNEES, their successors, assigns, nominees and legal representatives to obtain and enforce for its or their own benefit proper patent protection for said inventions or improvements in any and all countries.

AND, I hereby authorize and request the Commissioner of Patents and Trademarks of the United States and any official of any country or countries foreign to the United States whose duty it is to issue patents on applications as aforesaid, to issue to said ASSIGNEES, as ASSIGNEES of ASSIGNOR'S entire right, title and interest, any and all Letters Patents for said inventions or improvements, including any and all Letters Patents of the United States or any country or countries foreign to the United States which may be issued and granted on or as a result of the applications as aforesaid, in accordance with the terms of this assignment.
