WHEREAS I, **MATTHIAS KULLA**, a German citizen residing at Leonberg, Germany, have invented certain new and ornamental improvements in an

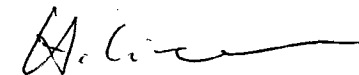
AUTOMOBILE
