## ASSIGNMENT

ASSIGNOR further agrees to execute any powers-of-attorney, applications, assignments, declarations, affidavits, and any other papers necessary to perfect such interest in ASSIGNEE, its successors, assigns and legal representatives.

ASSIGNOR hereby further agrees that he will communicate to said ASSIGNEE, or its successors, assigns and legal representatives, any facts known to him respecting any improvements in said invention. At the expense of said ASSIGNEE, ASSIGNOR agrees to testify in any legal proceedings; sign all lawful papers; execute all divisional, continuation, continuation-in-part, reissue, and substitute applications; make all lawful oaths; and generally do everything possible to vest title in said ASSIGNEE and to aid said ASSIGNEE, its successors, assigns and legal representatives to obtain and enforce proper protection for said invention in all countries.
