for which application is being made for Letters Patent, said application being identified as Attorney Docket No. **1321.002**.



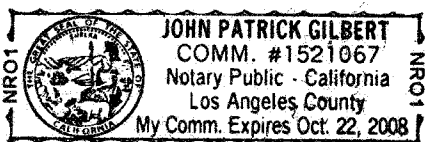
