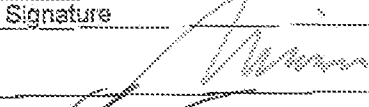
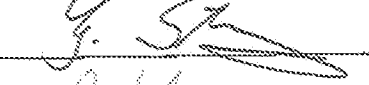
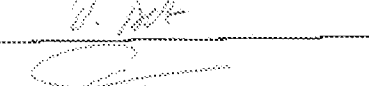
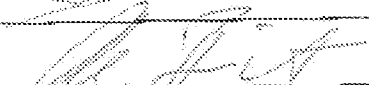
## ASSIGNMENT
