ASSIGNMENT OF PATENTS

Without limiting the APA: Assignor hereby warrants to Assignee that other than this Assignment, Assignor has made no assignment of the Patents and has not granted any license under any of the Patents. Assignor agrees to provide Assignee, at its request, all pertinent facts and documents relating to the Patents and will cooperate with and assist Assignee with any proceeding or litigation related thereto. Assignor agrees promptly to execute and deliver to Assignee confirmatory assignments relating to the Patents prepared by Assignee for recording by Assignee in the United States Patent and Trademark Office or any foreign governmental offices, and will promptly execute and deliver to the Assignee any and all other papers, instruments or affidavits and take all other actions required to assist Assignee with applying for, obtaining, maintaining and enforcing the Patents
