ASSIGNMENT AGREEMENT

This ASSIGNMENT AGREEMENT (the "Agreement") is dated December 11, 2008 and is between GenTek Holding, LLC, formerly known as General Chemical Corporation, ("Assignor"), and General Chemical Industrial Products, Inc. ("Assignee").

WITNESSETH

WHEREAS, General Chemical Corporation developed and/or owned valuable rights in certain patents ("Intellectual Property Rights") relating to soda ash, all as more fully described in ANNEX A attached hereto and hereby made a part hereof; and

WHEREAS, on November 3, 2003, General Chemical Corporation filed an amendment to its Certificate of Incorporation changing the name of the corporation to GenTek Holding Corporation; and

WHEREAS, on February 25, 2005, GenTek Holding Corporation filed a Certificate of Conversion, whereby it converted to a Delaware limited liability company named GenTek Holding, LLC; and

WHEREAS, GenTek Holding, LLC, as Assignor, desires to assign its Intellectual Property Rights to General Chemical Industrial Products, Inc. pursuant to the terms of this Agreement; and

WHEREAS, General Chemical Industrial Products, Inc., as Assignee, is willing to accept the assignment of the Intellectual Property Rights from GenTek Holding, LLC and to acquire all of GenTek Holding, LLC's Intellectual Property Rights as described in ANNEX A pursuant to the terms of this Agreement;

NOW, THEREFORE, in consideration of the mutual agreements and provisions contained herein and other good and valuable consideration, the mutual receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound hereby, the parties hereto do hereby agree as follows:


Assignor hereby sells, transfers, assigns, releases and sets over to Assignee all of Assignor's right, title and interest in and to said Intellectual Property Rights as described in ANNEX A, together with the rights attendant thereto, to have and to hold the same unto Assignee, its successors and assigns, from and after the date hereof, forever.
