ASSIGNMENT

WHEREAS, I, Marc BOTS, a citizen of the Netherlands, have invented certain new and useful improvements in and to the subject matter of:

NOVEL STRESS-RELATED MICRORNA MOLECULES AND USES THEREOF

described in US application No. 12/300,386, filed on November 11, 2008, based on International Patent Application No. PCT/EP2007/004142, filed May 10, 2007,

AND, WHEREAS, VIB VZW and UNIVERSITEIT GENT, both corporations organized under the laws of BELGIUM and having their place of business located at RIJVISSCHESTRAAT 120, BE-9052 ZWIJNAARDE, BELGIUM and SINT-PIETERSNIEUWSTRAAT 25, BE-9000 GENT, BELGIUM (hereinafter "ASSIGNEES"), are desirous of acquiring certain rights to the improvements and under the application;



AND I hereby agree for myself and my heirs, executors and administrators to execute without further consideration any further documents and instruments which may be necessary, lawful and proper in the prosecution of said above-referenced application or in the preparation or prosecution of any continuing, substitute, divisional, renewal, reexamination or reissue application or in any amendments, extensions or interference proceedings, or other applications for patents of any region or country, that may be necessary to secure to ASSIGNEES their interest and title in and to said improvements or any parts thereof, and in and to said several patents or any of them;

AND I hereby covenant for myself and my legal representatives, and agree with said ASSIGNEES, its successors and assigns, that I have granted no right or license to make, use or sell said improvements, to anyone except said ASSIGNEES, that prior to the execution of this deed, my right, title and interest in said improvements had not been otherwise encumbered, and that I have not and will not execute any instrument in conflict therewith;


AND I do hereby authorize and request the United States Commissioner of Patents and Trademarks to issue any and all letters patent which may be granted upon said United States applications, or upon said improvements or any parts thereof when granted, to said ASSIGNEES.
