## **ASSIGNMENT OF PATENTS**

The Assignee agrees to continue to maintain the Patent by prompt and timely payment of maintenance fees to the United States Patent and Trademark Office pursuant to 37 C.F.R. §1.362 and to perform all affirmative acts which may be necessary to maintain the Patents;
4. The Assignor and the Assignee hereby authorize and request the Commissioner of Patents and Trademarks and all equivalent foreign officials, to record this Assignment pursuant to 37 C.F.R. §1.332 and the Assignor warrants that the Assignor has full right to convey its entire interest herein assigned, and that the Assignor shall not and has not executed and will not execute any agreement in conflict herewith.
