RELEASE OF SECURITY INTEREST

WHEREAS, on October 31, 2005, Gerber Scientific, Inc. ("GSI"), Gerber Scientific International, Inc. ("Gerber International") as Borrowers and Gerber Coburn Optical International, Inc. ("Gerber Coburn") as Guarantor entered into a Loan and Security Agreement (the "2005 Loan and Security Agreement") with Citizens Bank of Massachusetts (the "Lender");


WHEREAS, on October 31, 2005, pursuant to the 2005 Loan and Security Agreement, GSI executed an Intellectual Property Security Agreement (the "GSI IP Security Agreement") in which GSI granted, assigned, transferred and conveyed to the Lender a security interest in all right, title and interest in the Collateral (as defined in the GSI IP Security Agreement) to secure the payment and performance in full of all obligations under the 2005 Loan and Security Agreement;

WHEREAS, the GSI IP Security Agreement was recorded with the United States Patent and Trademark Office on January 10, 2006 at Reel 017097, Frame 0668; and

WHEREAS, RBS Citizens, N.A. (as successor in interest to Citizens Bank of Massachusetts) hereby consents to the partial release of the Collateral, the partial release of the GSI IP Security Agreement, and the partial release of the 2005 Loan and Security Agreement limited solely to the Collateral listed on Exhibit A hereto (the "GSI Released Patent Collateral").

NOW, THEREFORE, RBS Citizens, N.A. releases the security interest in all right, title and interest in the GSI Released Patent Collateral granted by GSI pursuant to the October 31, 2005 GSI IP Security Agreement and the 2005 Loan and Security Agreement.
