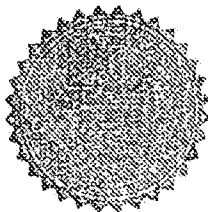

FIRST: The name of the constituent corporation is Omniglow Corporation, a Delaware corporation, and the name of the constituent limited liability company is GMS Acquisition Partners LLC, a Delaware limited liability company.
