## ASSIGNMENT

AND for the above consideration, the assignors hereby covenant and agree to and with assignee, assignee's successors, legal representatives and assigns, that the assignors are the sole and lawful owners of the entire right, title and interest in and to the inventions and the application, and that the same are unencumbered and that the assignors have good and full right and lawful authority to sell and convey the same in the manner herein set forth.

and desirable in connection with the inventions, or the application, or any proceeding in connection with the letters patent or patents for the inventions in any country, including interference proceedings, is lawful and desirable, or that any division, continuation or continuation-in-part of any application for letters patent or patents or any reissue or extension of any letters patent, to be obtained thereon, is lawful and desirable, sign all papers and documents, take all lawful oaths, and do all acts necessary or required to be done for the procurement, maintenance, enforcement and defense of the applications, patents or letters patent for said inventions, without charge to the assignee, the assignee's successors, legal representatives and assigns, but at the cost and expense of the assignee, the assignee's successors, legal representatives and assigns.

AND the assignor hereby requests the Commissioner of Patents to issue the United States of America patents to the assignee as the assignee of the inventions and the patents to be issued thereon for the sole use of the assignee, the assignee's successors, legal representatives and assigns.
