CONVENIO DE CESIÓN DE DISEÑO INDUSTRIAL

INDUSTRIAL DESIGN ASSIGNMENT
AGREEMENT

El suscrito, **FABRICE LEGROS** de nacionalidad Francesa, con domicilio en 6 rue des parisiens, 92600 Asnieres Sur Seine, Paris, Francia (en lo sucesivo el/la "CEDENTE"), declara que el diseño del Frasco con Tapa para perfume que figura inserto como **Anexo I** de este contrato, en adelante **EL DISEÑO**, fue diseñado de forma exclusiva para la **CESIONARIA**.

Por medio del presente Convenio, el/la **CEDENTE** cede, transmite, otorga y transfiere a perpetuidad todos los derechos existentes sobre **EL DISEÑO** en toda propiedad y dominio, incluyendo los derechos de reproducción, distribución al público, representación, adaptación y modificación de **EL DISEÑO** a través de los elementos técnicos y/o materiales existentes o los que existan a futuro, sea para fines comerciales u otros, especialmente para publicidad y fines promocionales, cesión que se hace libre de cualquier gravamen a favor de **Jafer Limited**, una sociedad constituida y existente de acuerdo a las leyes de Bermuda, con domicilio en Richmond House, 12 Par-la-Ville Road, Hamilton, Bermuda, (en lo sucesivo la "**CESIONARIA**") quien adquiere y recibe para sí la propiedad y titularidad de todos los derechos existentes sobre **EL DISEÑO** de parte de el/la **CEDENTE**, a su entera satisfacción. The undersigned, **FABRICE LEGROS**, French citizen, with domicile at 6 rue des parisiens, 92600 Asnieres Sur Seine, Paris, France, (hereinafter called the "**ASSIGNOR**"), declares that the perfume bottle with cap referred in **Exhibit I** (hereinafter **THE DESIGN**) was designed by himself exclusively for the **ASSIGNEE**.

The **ASSIGNOR** hereby assigns, conveys, and transfers in perpetuity all rights of **THE DESIGN**, including the rights of reproduction, distribution to the public, representation, adaptation and modification of **THE DESIGN**, on using all currently existing or non-existent technical means and/ or material, for commercial purpose or otherwise, notably for advertising and/or promotional purposes, free and clear of any and all liens or encumbrances to **Jafer Limited**, a corporation legally incorporated and existing under the laws of Bermuda, with domicile at Richmond House, 12 Par-la-Ville Road, Hamilton, Bermuda, (hereinafter called the "**ASSIGNEE**") and **ASSIGNEE** acquires and takes delivery of all rights of **THE DESIGN** from **THE ASSIGNOR** To its satisfaction. The assignment is referred to all available industrial property rights as well as to available copyrights only if applicable, and is effective internationally and worldwide.

THE ASSIGNOR also accepts that all or part of **THE DESIGN** may be filed and registered worldwide as designs and/or models and/or trademarks for all classes of products and/or services, or in relation to any other intellectual property right or similar provided for by the applicable local law, by **JAFER LIMITED** or any third party authorized thereby.

Moreover, **THE ASSIGNOR** shall refrain from copying **THE DESIGN**'s presentation or any feature, and/or from adapting it or using it as source of inspiration, for commercial purpose or otherwise, under his name or not.


La CESIONARIA autoriza a la CEDENTE a mencionar su nombre como el nombre del diseñador del DISEÑO.


ASSIGNEE is authorized hereby by ASSIGNOR to refer to his name as the designer's name.
