
AND WHEREAS, at the time the invention was made, I was under an obligation to assign all of my right, title, and interest in my said invention to Greatbatch Ltd.

And I further agree to sign and properly execute such necessary and lawful papers for application for foreign patents, for filing subdivisions of said application for patent, and for obtaining any reissue or reissues of any Letters Patent which may be granted for my aforesaid invention, as the assignee thereof shall hereafter require and prepare at its own expense.
