WHEREAS, we


- 1) Eitan Menahem, an Israeli citizen residing at Haetrog 4 Hadera, Israel;

NOW, THEREFORE, in consideration of One New Israeli Shekel (NIS 1.00) and other good and valuable consideration, the receipt of which is hereby acknowledged, we, as Assignors, hereby sell, assign and set over to said Assignee the entire and exclusive right, title and interest for Israel and all other countries of the world in and to said invention and the aforesaid patent application, and all rights to file, under the Paris Convention, and any other convention, patent applications based thereon and all divisional or other applications and patents applied for or granted therefor in Israel and in any other country, including all US national derivatives, and all patents which may be granted thereon and including international patent applications filed according to the Patent Cooperation Treaty (PCT) and all national/regional phase applications which will derive from the PCT applications, and all patents which may be granted thereon, and the undersigned for ourselves and our legal representatives, heirs and assigns do hereby agree and covenant without further remuneration, to execute and deliver all documents required for transferring said patents / applications to said Assignee or its assigns, to communicate to said Assignee or its representatives all facts known to the undersigneds with respect to said patents / applications, whenever requested, to testify in any legal proceedings in which the said patents or patent applications may become involved, to sign all lawful papers, make all rightful oaths, and to do generally everything necessary to aid said Assignee, its successors, assigns and nominees to register the assignment of the said Patent Application, the expenses incident to said application to be borne and paid by said assignee. The terms of this Deed of Assignment prevail over any other assignment or other deed, if any previously made in respect of the same matters.
