ASSIGNMENT

WHEREAS, COOPER INDUSTRIES, LLC, a Delaware corporation and successor to, by merger with, **COOPER INDUSTRIES, INC.** ("Assignor"), having its business at 600 Travis Street, Suite 5800, Houston, Texas 77002 (hereinafter referred to as "CI LLC"), is the owner of the full and exclusive right, title, and interest in and to the following inventions disclosed in United States Application No. 11/004,228, filed on December 6, 2004, titled CURRENT LIMITING FUSE (Docket No. 08215-573001 / RTC - 027108) (collectively, the "Inventions") by virtue of an assignment from the inventors to Cooper Industries, Inc. recorded at Reel/Frame 016322/0624 on March 2, 2005 in the U.S. Patent and Trademark Office and a merger of Cooper Industries, Inc. and Cooper Industries, LLC executed on January 1, 2005;

WHEREAS, COOPER TECHNOLOGIES COMPANY ("Assignee"), a corporation of Delaware (hereinafter referred to as "CTC") is desirous of acquiring the entire right, title, and interest in and to the Inventions, and any patents that may issue on the Inventions;

NOW THEREFORE, in consideration of the sum of U.S. \$1.00 (One Dollar), the receipt and sufficiency of which is hereby acknowledged, CI LLC does hereby sell, assign, and transfer unto CTC, its successors, assigns, and legal representatives, its entire right, title, and interest in and to the Inventions, and all patents that may issue on the Inventions, and all divisions, reissues, substitutions, continuations, and extensions of the Inventions, and all prior patents and patent applications from which a filing priority of the Inventions may be obtained, including, without limitation, all rights associated therewith, including the right to collect past damages; and CI LLC hereby authorizes and requests the Commissioner of Patents and Trademarks to issue all patents for the Inventions, or patents therefrom, to CTC.

CI LLC further agrees to execute any and all powers of attorney, applications, assignments, declarations, affidavits, and any other papers in connection therewith necessary to perfect such rights, title, and interest in CTC, its successors, assigns, and legal representatives.

CI LLC further agrees that it will communicate to CTC, or to its successors, assigns, and legal representatives, any facts known to CI LLC respecting any improvements; and, at the expense of CTC, to testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, reissue, and substitute applications, make all lawful oaths, and generally do everything possible to

vest title in CTC and to aid CTC, its successors, assigns, and legal representatives to obtain and enforce proper protection for the Invention in all countries.

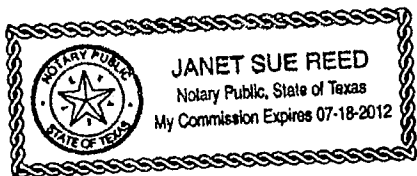
