ASSIGNMENT

WHEREAS, I, Teruo HIGUCHI, a citizen of Japan, have invented certain new and useful improvements in a:

VARIABLE DISPLACEMENT INCLINED PLATE TYPE COMPRESSOR

which are described in an application for United States Letters Patent, filed on July 22, 2008, and assigned Application No. 12/161,725;

AND I hereby agree for myself and each of my heirs, executors, and administrators to execute without further consideration any further documents and instruments which may be necessary, lawful and proper in the prosecution of said above-referenced application or in the preparation or prosecution of any continuing, substitute, divisional, renewal, or reissue application, of any request for reexamination, or in any amendments, extensions or interference proceedings, that may be necessary to secure to ASSIGNEE its interest and title in and to said improvements or any parts thereof, and in and to said several patents or any of them;




