COLLATERAL ASSIGNMENT

Although the parties intend that this Assignment shall be a present assignment, it is expressly understood and agreed that Secured Party shall not exercise its rights hereunder unless and until a default occurs in payment of any of the Obligations or in the performance or observance of any of the covenants or agreements set forth in any instrument now or hereafter evidencing or securing any of the Obligations.
