LICENSE TO THE UNITED STATES GOVERNMENT

WHEREAS, Peter N. Walsh, Syed S. Ahmad and Bradford A. Jameson, respectively, citizens of the United States, with respective post office addresses of 544 West Hottter Street, Philadelphia PA 19119, 6950 Eastwood Street, Philadelphia, PA 19149 and 810 W. Sedgwick Street, Philadelphia, PA 19119 have invented a new invention entitled "**PEPTIDE ANALOGS OF THE FACTOR IXa PLATELET BINDING SITE**" and filed an application for letters patent thereon in the United States Patent and Trademark Office, bearing Serial No. 08/172,330 with a filing date of December 22, 1993;

WHEREAS, the invention was made in the course of research supported by the Department of Health and Human Services; and

WHEREAS, the United States Government is entitled to certain rights in and to said invention and application by reason of the terms of such support; and

WHEREAS, Temple University-Of The Commonwealth System of Higher Education, hereinafter called the "Licensor" has acquired by assignment from inventors Walsh and Ahmad the entire right, title, and interest of those inventors to such invention;

NOW, THEREFORE

1. The Licensor, in consideration of the premises and other good and valuable consideration, hereby grants and conveys to the United States Government a royalty-free, nonexclusive, and irrevocable license for governmental purposes, and on behalf of any foreign government pursuant to any existing or future treaty or agreement with the United States of America, under the aforesaid patent application, and any and all divisions or continuations, and in any and all patents or reissues which may be granted thereon during the full term or terms thereof. As used herein, "governmental purpose" means the right of the Government of the United States, including any agency thereof, to practice and have practiced (made or have made, used or have used, sold or have sold) in connection with programs funded in whole or in part by the Federal Government throughout the world by or on behalf of the Government of the United States.

2. The Licensor covenants and warrants that he has the right to grant the foregoing license, and that any assignment which he may make of the invention or the said patent applications or patents thereon, shall expressly be made subject to this license.

3. The Licensor agrees that the Government shall not be estopped at any time to contest the enforceability, validity, scope of, or title to, any patent or application herein licensed.
